**The 2011 Sea Cavalcade Committee agrees to provide the following:**

1. Space for the vendor to set up their food kiosk.

**The Food Vendor agrees to provide the following:**

1. Self contained food kiosk ready to cook and serve food to the public.
2. Foods must be prepared in approved premises following the Health Department Guide Lines
3. Garbage cans, securely placed to avoid spilling and remove garbage
4. All necessary licences and health permits posted at site
5. All necessary insurance documents, naming the Sunshine Coast Sea Cavalcade Society and the Town of Gibsons as additionally insured. A minimum \$2million liability is required
6. All necessary safety materials (e.g. fire extinguishers)
7. To leave their site in the same condition that they found it.
8. Their own power supplies.
9. To pay a registration fee depending on the chosen date.

**Conditions:**

- Vendors handling food are required by the Department of Health that at least one person has a Food Service Right Certificate and must follow the regulations as requested in the health permit.
- The food vendor will pay the Sunshine Coast Sea Cavalcade Society 2011 Committee a registration fee and **20% of their net profit for the use of the site and the right to prepare and sell food during the festival hours.**
- Driving onto the site is limited for set-up and take-down only, no vehicles permitted on the field during the festival.
- The food kiosk must be securely positioned with sufficient space between it and the next kiosk.
- The food kiosk must be staffed for hours of the festival, no exceptions.
- Permission must be obtained from the committee to use portable power units.
